

Mileage reward on Chubb Travel Insurance – T&C

2. This promotion is available to Cathay members (“Members”) who have purchased **Chubb Premier Travel Cover** (Cover) for their journeys departing from Hong Kong and:
 - a) Purchase the Cover when they buy or redeem a flight ticket on Cathay Pacific Airways' website (https://www.cathaypacific.com/cx/en_HK.html); OR
 - b) Through Chubb’s [designated website](#) during the Promotion Period.
3. Eligible Member has to fill in the designated enrolment form on Cathay Pacific Website during the Promotion Period. Enrolment form must be filled within 7 days after your Cover purchase.
4. The Member must provide the correct Cathay Membership number, policy number and the Member's surname and first name in the form to earn the reward miles. Any missing or incorrect information may lead to failure in receiving the Miles.
